

Terms and Conditions for Retail and Distributorship of Investment Powder

1. Introduction:

- **Returns:** Returns are accepted within 30 days of delivery, provided the products are unused, undamaged, and in their original packaging. Return shipping costs will be the responsibility of the Retailer/Distributor.
- **Refunds:** Refunds will be issued upon receipt and inspection of the returned products. Refunds will be processed using the original method of payment.
